Welcome by Mr. Demirjie. Mr. D thanked the PTA for a successful gala. He thanked the PTA for their generosity to fund buses for each grade level for one field trip BIG THANK YOU.

LAUSD vaccine mandate for 12+ has been postponed til the end of the Spring 2021-2022 school year. If your child is not vaccinated in January they may still come to school.

Last year PRCS purchased a PSW – Psychiatric Social Worker. LAUSD has no employees and lots of empty positions. This position helps with SEL behavior of students. District taking all available employees to COA – City of Angeles, online instruction. We probably won't get that position filled til next semester. We transferred funds to hire a counselor. The position is flying now. Interview and selection will happen after we get receive candidates. We cannot wait. We need it for EL and MS.

To clear up any confusion, the first day of the next semester starts on 1/10/2022. LAUSD calendar shows 1/11/2022 but PRCS will not take a pupil free day on 1/10/2022 and last day of second semester is 6/9/2022. 904 schools choose the same pupil free day as we did. Ms. Cullen, PRCS UTLA rep says MISIS will be fixed to the correct date. LAUSD is writing a code to fix the date.

Public comments can be expressed for 2 minutes at the GSC meeting. We only have to listen to the comment. We do not need to respond.

Ms. Cullen motioned to approve the 11/18/2021 minutes. Betty seconded. All approved.

Our PRCS IMA (instruction Material Budget) is \$41,267 to purchase materials for school. We do not need to decide or spend it now. We just need to know that we can spend it. Money rolls over each year.

Mr. D apologized that the budget was not ready last month. Adrienne asked if there were any requests at this time. Mr. D responded that there were no requests at this time. Teachers come to Mr. D, Ms. Diaz first then Booster if the request is not funded through our IMA.
